PRIVACY POLICY

2. Information We Collect. We collect personal information that you provide directly to us, as well as information collected automatically through your use of our website.

- This includes name, email address, mailing address, phone number, and any other details provided via web forms.
- If you donate, we may collect information required by law to be reported to election authorities, including your employer and occupation.
- We use cookies, pixels, and similar technologies to collect information about your device, IP address, and how you interact with our site to improve the user experience and analyze traffic.

3. Use of Information. We use the information we collect to:

- Communicate with you regarding the campaign and your involvement.
- Process and report contributions in accordance with applicable law.
- Optimize campaign strategy and website performance.
- Comply with legal obligations and protect our rights.

4. Disclosure and Sharing of Information. We do not sell your personal information. We may share your information as follows:

- We share information with vendors, consultants, and other service providers who need access to such information to carry out work on our behalf. These providers are prohibited from using your information for their own purposes.
- We may disclose information if we believe disclosure is required by any applicable law, rule, or regulation, or to comply with law enforcement or legal process.
- We may share information with your express consent.

We will not share or sell your text messaging opt-in data, consent, or related personal information with any third parties, unless required by law.

The foregoing does not apply to sharing (1) with vendors, consultants and other service providers who need access to such information to carry out work on our

behalf (and who will not use such information for their own purposes); (2) if we believe disclosure is required by any applicable law, rule, or regulation or to comply with law enforcement or legal process; and (3) if the user consents to our sharing of such information.
